- The exciting transformation of Regatta Park along the riverbank, from River Road to the river foreshore, is well underway. Preparation work on the western section of Regatta Park will start shortly and run through until the end of the year.

This preparation work includes some tree removal and leveling of groundwork to prepare for the River Road deviation and new road corridor. A number of utilities, including water and gas, are also being relocated.

We'll be working closely with the contractor to minimise disruption for surrounding residents and visitors to the Nepean River by communicating any noisy activities in advance, making sure no work is done before 7am or after 6pm, or on weekends.
