- The transformation of Regatta Park into Western Sydney's newest focal point for nature, leisure and recreation is now one step closer with construction on the \$24 million upgrade underway. The first stage of construction is focused along the riverbank, from River Road to the Nepean River, and this section is temporarily closed until December 2021. The eastern car park is also permanently closed.

This section of Regatta Park will feature a 112-metre pavilion with undercover play space and water features, a new amenity block, a pathway down to the river foreshore and several over-water viewing platforms. An adult change facility in the amenities block on the western side of River Road is also being delivered. The car park and amenities block on this side of River Road remains open, as does the Great River Walk.

The construction of Regatta Park is expected to take 18-months, with the project set to be complete in December 2022. More information can be found at penrith.city/regattapark

- Penrith City Council is inviting the community to provide feedback on the Draft College, Orth and Werrington Creeks and Draft Little Creek Catchment Floodplain Risk Management Study and Plan between Thursday, 29 July to Thursday, 26 August 2021.

College, Orth and Werrington Creeks study area is approximately 12 km2 and covers the suburbs of Werrington, Werrington County, Cambridge Park, Kingswood and Caddens, roughly bounded by the M4 Motorway in the south and Dunheved Road in the north. Little Creek Catchment study area is approximately 4.8 km2 and covers the suburbs of Colyton, Oxley Park, St Marys and North St Marys, roughly bounded by the M4 Motorway in the south and Christie Street in the north.
