Penrith City Council is involved in litigation in the Land and Environment Court in relation to a Development Application in respect of the subject property. The name of the applicant is Catholic Metropolitan Cemeteries Trust.

Section 10.4 of the *Environmental Planning & Assessment Act 1979*, and the *Local Government Act 1993*, requires the disclosure of reportable political donations or gifts by a person or persons who makes a relevant planning application to Council or submission on a relevant planning application to Council.
