COUNCIL BRIEFS

- Council has teamed up with the Museum of Contemporary Art Australia for this year's exciting C3West program, Skirts - examining issues around women's community safety in the suburb of Kingswood.

Working with Western Sydney-based artist Linda Brescia, Skirts brings together women from Kingswood and surrounding suburbs who have a common vision – they aspire for positive change for themselves, each other and their community.

- Penrith Council is now accepting Private Certifier Applications online through the NSW Planning Portal. Each step of the application is clear and simple, and is faster and more efficient for everyone.

- The \$24 million upgrade to Regatta Park will begin shortly and the eastern car park, closest to the Nepean River, is now closed to allow remediation work to start on site. The riverbank, from River Road to the river foreshore, is also temporarily closed until November.

The first stage of construction includes delivering a 112-metre pavilion with undercover play space and water features, a new amenity block, an accessible pathway down to the river foreshore and several over-water viewing platforms. An adult change facility as an extension to the amenities block on the western side of Regatta Park is also being delivered.

The car park and amenities block on the western side of River Road at Regatta Park and the Great River Walk remains open during construction. Alternative parking options at the Nepean River include on-street parking along Tench Avenue, Tench Reserve car park and the Emu Plains commuter car park on weekends.
