## **COUNCIL BRIEFS**

 Penrith City Council will start construction on the Harold Corr Athletics Track Upgrade this month as the existing sports oval in Herbert Street, Cambridge Park, is transformed into an athletics precinct featuring an all-weather synthetic track – the first of its kind in the Penrith LGA.

The \$5 million project is being jointly funded by Council (2.8 million), the NSW Government (\$2 million) and the Australian Government (\$303,341). The first stage will deliver a synthetic athletics track and field facility, floodlighting and a formalised carpark.

This upgrade will benefit athletics clubs and schools whilst promoting greater sporting and recreation opportunities for local residents. The site will close to the public in early September and re-open in September 2022.
