# **PUBLIC NOTICE**

Tench Avenue, Jamisontown – Proposed the implementation of signs and line marking changes

As a result of community concerns and traffic queuing, Council is proposing four treatments to improve traffic flow and the functionality of the existing boat ramp at Tench Ave, Jamisontown as follows:

### Treatment 1:

Direct vehicles with boat trailers from the west, to the western parking area for vehicles with boat trailers to increase the queuing capacity from 30 metres currently, to 180 metres.

### Treatment 2:

Install 'No Left Turn for Vehicles with Boat Trailers', and 'No Right Turn for Vehicles with Boat Trailers' on Tench Avenue (western and eastern legs of the roundabout) and 'No Entry for Vehicles with Boat Trailers' at the northern leg of the roundabout.

### Treatment 3:

Change the One-Way entry (road entry between the western car park and the eastern car park) to two-way traffic and provide a pavement texture to allow vehicles to access/egress from the car parks to Tench Avenue.

### Treatment 4:


Change the current 'No Stopping' signage to full time 'No Stopping' signage north east of the roundabout in Tench Avenue to improve safety and eliminate trip hazards.

The abovementioned treatments will improve motorist safety when entering and exiting the car park,

improve sight distance and manage the priorities along the nominated sections.
