The Food Organics and Garden Organics (FOGO) service was introduced in July 2019 to those suburbs, and ever since, they've been FOGOing like legends and have diverted 4,251,000kg from landfill, that's the equivalent of 567 FOGO truck loads!

Separating organic items such as meat, bones, prawn shells, eggshells, coffee, tea, garden vegetation and even cardboard food containers like pizza boxes, means that it gets processed into compost which is reused within the community.
