 The Nepean River is one of Penrith's greatest assets and the ability to enjoy water activities such as kayaking and boating so close to home brings joy to many of us.

From now until March 2022, Council will be publishing weekly water quality data for four locations along the Nepean River, including:

- Tench Reserve, Jamisontown;
- Regatta Park, Emu Plains;
- Rowing Club (Nepean River Weir), Penrith; and
- Devlin Road, Castlereagh.

Visit **penrith.city/waterquality** to gauge for yourself the water quality at the above locations.

 Portable and inflatable pools have the same drowning risk as permanent pools. In fact, 1 in 5 of the swimming pools in which children drowned between 2006 and 2015 was portable.

To help prevent child drowning, make sure you have a compliant pool barrier that is used correctly and maintained regularly, ensure there's an adult within arm's reach of swimming children, teach children water familiarisation and swimming skills, and learn CPR.
