Penrith Council operates under the Home Jurisdiction Rule – this means that the Local Government Area (LGA) in which your vehicle is ordinarily garaged is your 'home council'.

If your vehicle is garaged within the Penrith Local Government Area (LGA) when not in use, Council will contact you to arrange a time for you to present the vehicle for an inspection. Your vehicle must be inspected once a year.

If your vehicle does not comply with the Mobile Food Vending Guidelines, Council may request that you complete works to fix any issuess before you can trade at the nominated location.

If your vehicle is garaged outside the Penrith LGA, Council will accept an inspection report (less than 12 months old) from your home council. You will also need to notify your home council of your intention to trade in the Penrith LGA. More information is available in the Mobile Food Vending Guidelines.

The activity will not result in any damage to public property on the land or on adjacent land, and

If the activity is carried out on land within or immediately adjacent to a residential zone-only be carried out between 7am - 7pm on any day, and

The activity is limited to one development on that land and not contravene any conditions of a development consent for any other use carried out on the land.

Note: A registrable vehicle within the meaning of the <u>Road Transport (Vehicle Registration)</u> Regulation 2007, or a cart, bicycle cart or the like must operate in accordance with the <u>Guidelines for Mobile Food Vending Vehicles (NSW/FA/F1055/1302)</u> published by the NSW Food Authority in February 2013, and any requirements of the <u>NSW Food Act 2003</u>.
