## 'OUT OF AREA' /NON RESIDENT SURCHARGE

1. 'Out of area' is outside the boundaries of the Penrith local government area (LGA).
2. The 'out of area' surcharge does not apply if the deceased is a resident of Penrith LGA at time of death. Proof of residency of the deceased **may be** requested.
3. The 'out of area' surcharge does not apply if the deceased was a resident of a nursing home outside the city but their last address is in Penrith LGA. Proof **will be** requested.
