## SAFE AND LEGAL PARKING

## COMMONLY MISUNDERSTOOD PARKING RULES

Learn more about parking and vehicle restrictions in the Penrith City Council local government area to help avoid infringements and keep the community safe.

## ANGLE PARKING

Ensure you angle park at the kerb as indicated by the posted signs and/or the road line markings.

Always park your vehicle as directed by the sign. If there is no direction on the sign, always park the front of the car to the kerb.


- Not angle park as on parking control sign or road marking penalty exceeds $\$ 114$.


## DISABILITY <br> PARKING

Only vehicles transporting a current Mobility Parking Scheme (MPS) permit holder can park in areas displaying this sign. The MPS permit must be displayed in the parked vehicle. MPS permit holders must comply with the conditions of use of the MPS permit.


## TIME LIMIT FOR <br> MPS HOLDERS

| Sign Posted Time Limit | MPS Permit Limit |
| :--- | :--- |
| Less than 30 minutes | Maximum 30 minutes |
| 30 minutes | Up to two hours |
| More than 30 minutes | Unlimited |

## CONDITIONS OF USE FOR MPS PERMITS

- The permit must be inserted and displayed in the plastic sleeve of the Australian Disability Parking permit provided to you by Transport for NSW.

- The permit must only be displayed when the vehicle is being used to transport the permit holder.
- The permit should be displayed unobscured, so the expiry date and card details are visible.
- The permit may be confiscated by an authorised officer and/or revoked by Transport for NSW for misuse or breach of any of these conditions.
- The permit is not valid if reproduced, copied, defaced or otherwise altered or where one or more of the details on the permit (e.g. card number or expiry date) are illegible.
- Parking concessions available under the Mobility Parking Scheme are only valid in council operated car parks or on public streets.
- Stop in disabled parking area without current permit displayed penalty exceeds $\$ 572$ and occurs 1 Demerit Point.


## HEAVY/LONG VEHICLES IN BUILT-UP AREAS

## WHY IS IT ILLEGAL?

Parking a long or heavy vehicle in a built-up area for longer than one hour can cause damage to the road infrastructure, cause traffic congestion and obstruct sight distances. Heavy vehicles usually generate a high level of noise.

A heavy vehicle means a vehicle with a GVM of 4.5 tonnes or more.


A long vehicle means a vehicle that, together with any load or projection, is 7.5 metres long or longer.


- Stop heavy/long vehicle longer than one hour penalty exceeds \$114.


## RESTRICTED <br> PARKING AREAS

Restricted parking areas are used in large public areas that usually have a limited number of entry and exit points.

You must not park your vehicle between the signs "RESTRICTED PARKING AREA" and "END RESTRICTED PARKING AREA", except in a marked parking bay in accordance with the signs.

## RESTRICTED PARKING AREA <br> PARK IN BAYS ONLY

## END <br> RESTRICTED PARKING AREA

- Stop in restricted parking area penalty exceeds $\$ 114$.


## PEDESTRIAN AND CHILDREN'S CROSSING

A vehicle must not stop on a pedestrian or children's crossing, on the road within 20 metres before the crossing or 10 metres after the crossing, unless the posted sign states otherwise.


- Stop on/near pedestrian crossing penalty exceeds $\$ 344$.
- Stop on/near children's crossing penalty exceeds $\$ 344$.
- Penalties for School Zone offences exceeds \$457 and two Demerit Points.


## PARALLEL PARKING

This is the most common way of parking unless the posted sign states otherwise.

You must park in the same direction as the flow of traffic, close and parallel to the kerb. You must leave at least three metres for another vehicle to get around you.

- Not parallel park within three metres clear road alongside (no dividing line/strip) penalty exceeds \$114.
You must not park within three metres of any unbroken dividing line.
- Parallel park close to dividing line/strip penalty exceeds $\$ 268$.


You must not stop within three metres of a post box unless you are posting a letter, and stand for no longer than two minutes.

- Stop near Post Box penalty exceeds \$114

You must always leave one metre clearance between vehicles.


- Parallel park close to front/back of vehicle penalty exceeds $\$ 114$.
